The Board hereby announces that on 11 June 2025, Yueda Commercial Factoring, an indirectly wholly owned subsidiary of the Company, entered into a reverse factoring agreement (the "Reverse Factoring Agreement") with Yancheng Shuanghu. REVERSE FACTORING AGREEMENT

The Board hereby announces that on 11 June 2025, Yueda Commercial Factoring, an indirect wholly owned subsidiary of the Company, entered into Reverse Factoring Agreement, pursuant to which Yueda Commercial Factoring agreed to provide Accounts Receivable Services and granted reverse revolving factoring financing credit limits to Yancheng Shuanghu and Yancheng Shuanghu is entitled to apply for accounts receivables transfer and factoring services. If Yancheng Shuanghu needs financing facility from Yueda Commercial Factoring, it will make an application for factoring services. If the credit assessment is to the satisfaction of Yueda Commercial Factoring, Yueda Commercial Factoring will grant the factoring financing within the reverse revolving credit limit.
